#### WHAT IS A SAFE HAVEN PROGRAM?

A confidential path for individuals to seek help for burnout, mental health or substance use disorders or other medical conditions. A therapeutic alternative to regulatory action for chronic illnesses.

- Screening
- Referral for treatment or support

# WHO ADMINISTERS THE OBN SAFE HAVEN PROGRAM?

OhioPHP is the designated monitoring organization for OBN. OhioPHP protects the confidentiality of program participants and referral sources to the fullest extent allowed by law.

#### How do I enroll in the safe haven program?

If you or a colleague needs help, contact OhioPHP. OhioPHP's clinical team may conduct a well-being screening and then will provide recommendations that may include additional evaluation for burnout, mental health or substance use disorders, individual counseling, and/or any necessary treatment. Once a diagnosis has been made, licensees may enroll in long-term, therapeutic monitoring through the safe haven program.

### What if I participate in a multistate licensure compact?

Per Ohio law, an applicant cannot obtain, nor can a licensee retain the multistate license privilege when currently enrolled in the safe haven program. OhioPHP is required to notify the Board of Nursing of any licensee or applicant who enrolls in the safe haven program for deactivation of the multistate licensure privilege for the duration of the nurse's participation in the safe haven program. Participation will be noted on NURSYS.com for other Boards of Nursing.

### Is there a cost associated with the safe haven program?

OhioPHP has a sliding-scale structure for its fees. This ensures that we can continue to provide high-quality support while accommodating the diverse needs of our community.
